Customers are requested to purchase only authorised handsets from GRID or its appointed resellers.</p> <p>1.7 We/I agree that there is a requirement to have a Push-To-Talk one-to-one communication service as part of the subscribed services, regardless of the specific subscribed services applied for. Upon the expiry date of any other subscribed services subscribed to, we/I agree to an automatic extension of its subscription of the Push-To-talk Service, at the charged rates applicable on the date of extension.</p>			
<b>2 TRANSFEREE'S UNDERTAKINGS</b>
